- If the Petition is balloted on favorably, the secretary will fill in the Request for Transfer of Membership form, affix the seal, sign in the designated place, and send to the member's current Chapter.
- When the Transfer Certificate is returned and read to the Chapter, the transfer is complete.
- The Transfer Certificate must be attached to the petition and both retained in the Chapter files.
